

# Child Protection and Safeguarding – Information and Resources

#### What to do if you are concerned about a child

\*\*\* If your child is in immediate danger you should always phone 999 \*\*\*\*

If you have concerns about a child that are not an emergency, contact the specialist team at the <u>AfC Single Point of Access (SPA)</u> on 020 8547 5008 (Monday to Friday 8am-6pm) or out of hours 020 8770 5000. The SPA team are specifically trained to handle your enquiries, liaising with other teams to investigate concerns. The team also provides information and advice across a range of child and family services and is open to all (practitioner/member of the public).

**The Local Area Designated Officer (LADO)** works within Children's Services (AfC). They should be informed of all cases in which it is alleged that a person who works or volunteers with children has:

- behaved in a way that has harmed, or may have harmed, a child
- possibly committed a criminal offence against children, or related to a child
- or behaved towards a child or children in a way that indicates they are unsuitable to work with children.

# **Charity Trustees Responsibilities**

The Charity Commission is very clear that all trustees of a charity (including management committee members of those that are too small to be registered) hold responsibility for safeguarding and must proactively take steps to prevent people, both children and adults, from being harmed through contact with their organisation. #### **Duty to Refer**

If you remove a worker or volunteer from working in a regulated activity with children or adults in risk (or would have if they had not left first) because they pose a risk of harm to a child or vulnerable adult, you **must** make a referral to the Disclosure and Barring Service.
